Battle of the Pigs & Car Show is a two-day event (May 28-29, 2010). Set up for most food vendors will begin at 7am and must be completed no later than 2pm on Friday, May 28, 2010. (Vendors with special permission may begin setup at 4pm on Thursday, May 27, 2010). All food vendors must remain set up until 10pm on Friday May 28, 2010 and until at least 10pm on Saturday, May 29, 2010 (Booth area can not be removed until after the close of the event at 11pm due to safety concerns). Food vendors will not be able to sell drinks at their booth. Security will be provided overnight, but we recommend that very valuable merchandise be removed when not in attendance. Vendors must be set up again by 9am May 29, 2010. No cars or trailers are allowed on the premises from Friday May 28 at 3:00pm to Saturday May 29 at 10:00pm for safety reasons.

All applications for food vending at Battle of the Pigs & Car Show will be reviewed. Sending in an application is NOT a guarantee of vending at Battle of the Pigs & Car Show. Food vendors will receive notice of their vending status via US Mail.

BBQ Food Vendor Booth Fee for May 28 & 29, 2010: \$450 (20 x 30)
Space is limited, reserve your spot today.

All food vendors must comply with Tennessee Health Codes, pay the \$30 Health Permit fee and undergo an onsite inspection of vending area prior to the sale of any food.

Checks will be promptly returned to those vendors not selected to participate.
